The Puerto Rico Advisory Committee to the U.S. Commission on Civil Rights will hold a series of virtual panels focusing on access to federal programs and the role of race and ethnicity as part of its study on the Insular Cases and the Unincorporated Territory Doctrine and its effect on the civil rights of residents of Puerto Rico.
